**MLS Photo Submission Policy**  
**When is a photo due?**  
 Once a property is submitted to the MLS, you have 72 hours to submit the photo. (does not include weekend or non-working holiday). If a photo is not received within 72 hours the Broker will be billed \$25 per day until primary photo is uploaded.  
 \*Single Family, Multi-family, Duplex and Condo require a photo. (even if they're Sold Before Print, 1 - party listings, or In-House listings)  
 \*FSBO, Commercial, Vacant Land, and Business photo is not required. (although photos are welcomed)

**New Construction**  
 If the property is New Construction, meaning there isn't a structure yet (defined as siding, windows, and roof), it is very important that you send an email notifying the MLS coordinator - [mls@larawebsite.com](mailto:mls@larawebsite.com). If no notice, and no photo submitted within 10 days, the Broker will be billed \$12 per listing on the 25<sup>th</sup> of each month until that photo is submitted or correspondence is received explaining that the listing has no structure. If the listing is determined as New Construction, the MLS Coordinator will call once a month to check the status. Once there is a structure, you are required to submit a photo within 10 days.
